Whether foreseen or unforeseen, arising directly, or indirectly out of any damage, loss, injury, or death to me or my property in any way connected to my participation in recreational events and activities or my use of **Landowners Co-op Hunting Club's** equipment, property or facilities. I agree that neither I, nor anyone acting on my behalf will make a claim of any kind against **Landowners Co-op Hunting Club** as a result of any damage, loss, injury, or death to me or my property. I understand that in signing this agreement, I surrender my right to make a claim or file a suit against **Landowners Co-op Hunting Club** for my personal injury, property damage, wrongful death or otherwise, except in the cases of **Landowners Co-op Hunting Club's** intentional conduct of gross negligence. The venue of any dispute that may arise out of this agreement or otherwise between the parties of which the **Landowners Co-op Hunting Club** or its agents or landowners is a part shall be either the Lewiston of Idaho, Justice Court of the County or State Supreme Court of Nez Perce County.
